	The maximum permissible structure height is 6 m, insofar as this is permitted by the height of the hall ceiling and any fixed installations that may be present.
	The sides of the stand opening onto an aisle may not be closed off by stand walls or other visual barriers to a maximum of 30 % along their entire length without the Organiser's approval.

Stand construction approval Deadline: 11.08.2023

Stand construction approvals are mandatory under the following conditions:

// two-storey construction

// special glass constructions

// podiums, stairways, bridges, galleries

// structural installations that have to bear extraordinary loads or forces, etc.

Please pay particular attention to points 4.7.7 Ceiling constructions for stand construction, point 4.9. two-storey construction to point 4.9.3. payload/ load assumption of Messe Düsseldorf's technical guidelines.

For all other stands, urgent compliance with the technical guidelines as well as the specifications from the item "Information on stand construction" from this checklist applies.
